



#### Why am I doing this?

Because parking bays can be used for more than just parking cars.

When I offered the Council full price for an annual parking permit they refused because I do not have or want a car. Instead I wanted to show how the same space could be used... I'm afraid I took matters into my own hands.

Households in Hackney who don't have a car number twice as many as those that do. Yet all our kerbside space is devoted to car parking. And cars are parked - on average - for 95% of the time. What a waste! Surely we can find a better use for at least some of our precious roadside space?

Why not allow people to park themselves along a road instead, or give children a space to play, or simply have something lovely to look at, say, a mini-garden?

This is just one quirky example of what we could do in a parking space. Please do park yourself here, as long as it lasts.

Pro-walking campaigner Brenda Puech was refused permission by the council to pay for a parking space for anything other than a car.







# 'Parklets' could transform the streets of Cambridge, say campaigners

Parking spaces on the streets should not just be used for cars, it is being proposed

Miniature constructions called 'parklets' are transforming streets in cities around the world — and now people say they should exist in Cambridge.

Campaigners are calling for the introduction of these pint-sized hang-outs after a woman in London created a sensation by building one on her street without the council's permission.

Brenda Puech, 54, from Hackney, decided to build a parklet after Hackney Council told her she could only use a parking permit for a car.

"I felt, if you don't have a car, why shouldn't you be allowed to have a parking space," said Ms Puech, a disability access consultant. "For me it is a civil liberties issue as much as anything else."

According to Ms Puech, parklets originated in San Francisco and are built in parking spaces next to the pavement to create extra space for pedestrians to stop and relax.

Asked if a parklet could work in Cambridge, she said: "I think that would be wonderful. It makes a great community focal point and it shows that you can use spaces for alternatives to cars."

A Cambridgeshire County Council spokesperson said: "The County Council has an approved policy for the management of parking across the county.

"We work closely with local communities to ensure the application of our policy is effective and meets their needs. Any changes to how road space is used involves full consultation with the elected members residents and businesses."



"I believe a programme could be developed that harnesses people's creativity and willingness to invest in the street outside their home and that enhances the public realm, without costing the tax-payer any additional money."

Brenda Puech wants to see 'people parking bays' on every street in the borough, where residents and businesses can place something apart from a car for communal use in a bay when they buy a permit.

"This does not have to cost money for local authorities, or even lose them car parking revenue," said Puech. "Parklets are common in San Francisco, New York and many US and European cities."

The number of households in Hackney and other inner London boroughs that do not have a car outnumber car owning homes by two to one, according to Puech. "Yet all our kerbside space is given over to car parking. What is worse, cars in London are parked on average 96% of the time. This is a waste of valuable street space. A public resource - the street - is being allocated very inefficiently.

"With a decrease in car ownership and car use in cities, are we allocating too much space for cars and not enough for other uses? Walking is the most common way for people to get around and yet car parking dominates kerbside space. There is little or no provision for walkers to rest. Many people, including older and disabled people, and people with kids need regular rest stops while walking, and many pavements are too narrow for walking, let alone for benches."

# Hackney resident wants to convert parking bays into people places

A Hackney resident has launched a campaign to turn surplus on-street parking spaces into car-free 'people parking bays'. Brenda Puech contacted the London Borough of Hackney to request an annual parking permit as she wanted to install a bench, cycle stands and plants in the bay outside her home.

Her request was turned down by the authority, which said the permit could only be used for parking a vehicle.

Undeterred, Puech organised a 'direct action' event on 26 May, transforming the space outside her home into a 'people parking bay'.

The action was supported by London Assembly member Caroline Russell, who said: "I'm delighted to support Brenda Puech's people's parking bay direct action which humorously and gently points out the absurdity of confining the use of precious street space for storing cars.

"With car ownership plummeting it seems extraordinary that residents who don't own

cars cannot pay to use road space for small parklets that beautify the street and make streets into less hostile and more sociable places.

A green campaigner who turned a parking space into a garden has won her latest battle with a London council.

Brenda Puech began setting up her People Parking Bay in different locations in Hackney over a month ago, complete with a fake lawn and garden furniture.

The gardens proved a huge hit among locals, but Hackney Council has removed the makeshift bay due to complaints from drivers.

After a month-long row with the 54-year-old, the council has now agreed to meet with Ms Puech next week to "come up with a solution that works for everyone".







### Why are the pop-up parklets temporary and only in Shoreditch?

We know that there is a demand for parklets across the borough. The pop-up parklets are an opportunity for us to see what works, and how they could be rolled out more widely.

In the future we want to provide a way for local residents to suggest locations and uses for more permanent parklets everywhere - Car Free Day is just the start.

## Are parklets the future for parking bays?
